What impact has the rapid change in information technology and resources had on information brokers?

- ◆ Explosion of the Internet, particularly commercial sites
- ♦ Loss of privacy and security on the Internet
- ♦ Internet culture electronic anarchy, resistant to fee-based Net services
- ◆ Need for information NOW, not next week, not tomorrow
- ♦ Shrinking of the world dramatic increase in need for international information
- ♦ Awareness of the availability of open source information
- ♦ Competing sources of information commodification of information
- ◆ RIFs and downsizing means fewer people having to do more with less
- ♦ Need for added-value by information brokers no more rip-and-ship

What trends will have the biggest impact on information brokers over the next 5 years?

- ♦ Internet, where the only constant is that it's constantly changing
 - •staying on top of rapidly-changing protocols
 - •explosive growth of traffic means sites are down and response time is slowed
 - •concerns about security and viruses
 - "I already looked on the net... where else would I possibly need to go?"
 - ."Why does your research cost money? Isn't the Internet free?"
 - "I'm sure the information's there. I found info on breeding pot-bellied pigs so everything must be on the Net."
- ♦ Emergence of "information on the desktop"
- ♦ Niching of online services
- ♦ Not everything will ever be available online
- ♦ Dumbing-down of online services
- ♦ Copyright issues who owns RAM-space? How do you protect copyright?

Where will information brokers shine in the next 5 years?

- ♦ Synthesis of information transforming data into knowledge
- ♦ Creating order from Net chaos
- ♦ Serving as a hired gun... you pay only for what you need
- ♦ Serving as local expert do what you do best and hire the rest
